2.1 Request to Retain 2019/2020 Community Grant - Tairua Care and Friendship Club, Tairua Troubadours and Pauanui Half Marathon

1 Purpose of report

The purpose of the report is to seek Community Board approval for the Tairua Care and Friendship Club, the Tairua Troubadours and Pauanui Half Marathon to retain all or a portion of their unspent 2019/2020 Tairua-Pauanui Community Board grant.

2 Summary

Point 14 in the Tairua-Pauanui Community Board Grants criteria states that: Any Community Grant funds not spent on the project for which the funds were applied for by the close of the Council's financial year must be returned to the Thames-Coromandel District Council unless written approval to retain the funds is obtained from the relevant Community Board.

The Tairua Care and Friendship Club applied for a grant through the 2019/2020 Community Grant process to cover hireage of the Tairua Hall and have asked for some of these funds to be carried over to the 2020/21 financial year due to the COVID 19 lockdown. The Club have also advised that hall hire will also be increasing.

The Tairua Troubours applied for a grant through the 2019/2020 Community Grant process to cover hireage of the Tairua Hall and have asked for the funds to be carried over to the 2020/21 financial year as the show has been postponed due to COVID 19.

The Pauanui Half Marathon applied for a grant through the 2019/2020 Community Grant process to cover costs associated with their running event and have asked for some of these funds to be carried over to the 2020/21 financial year. The event has been postponed until December 2020 due to COVID 19.

The Tairua-Pauanui Community Board needs to consider whether it wishes to approve retention of the funds to the Tairua Care and Friendship Club, Tairua Troubadours and Pauanui Half Marathon

The Tairua Care and Friendship Club Inc. have requested the retention of \$576.00 of their grant of \$1,000.

Tairua Troubadours have requested the retention of their whole grant of \$1,000.

Pauanui Half Marathon have requested the retention of \$12.37 of their \$2,250.

3 Suggested resolution(s)

That the Tairua-Pauanui Community Board:

- 4. Approves the retention of the Pauanui Half Maration \$12.37 unspent grant to be spent in the 2020/21 financial year.
